Liability insurance

District VII has recommended that all chapters purchase liability insurance. The recommended amount is \$1,000,000 for any one occurrence to protect the organization, its officers and members against claims by others for bodily injury or property damage caused by the negligence of the chapter. For a non-profit organization, payments are reasonable (\$150-\$350 per year) Tina Crawford, Regent of Craig Valley Chapter, has written an article on the benefits of liability insurance (attached with this newsletter).
